Tuition is based on a yearly price broken down into monthly increments. The monthly payment is the same whether there are 3 or 5 classes in a month. This includes holidays as well. There is no refund for a missed class due to sickness or vacations.

## **Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 has been reported extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact of contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms (asymptomatic) and therefore spread the disease without knowledge. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. **Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.**
